

THIS CAUSE, coming on to be heard before the Honorable Judge Warren McSweeney presiding over the Moore County District Court regarding Plaintiff's Complaint for a Civil No-Contact Order pursuant to N.C. Gen. Stat. 50C, the parties having consented to the entry of a Civil No-Contact Order. The parties have reviewed and signed this Consent Order. Based upon the parties' agreement, this Court hereby makes and enters the following:

FINDINGS OF FACT

- 1. Plaintiff is and has been for more than six (6) months immediately preceding the filing of this motion, a citizen and resident of Moore County, North Carolina.
- 2. Defendant was formerly a citizen and resident of Moore County, North Carolina, and is currently residing in the State of Massachusetts.
- 3. Plaintiff filed a complaint for a Civil No-Contact Order on July 17, 2020.
- 4. The parties waive any further Findings of Fact and consent to the provisions set forth in the Order herein.
- 5. The parties waive any right they may have in regard to the *Macintosh v. Macintosh*, 74 N.C. App. 554 (1985) decision by their notarized signatures below. The parties have entered into this agreement freely, knowingly and voluntarily. Neither have been coerced into entering this agreement and their consent is freely and voluntarily given. The parties acknowledge that they have read and understand this Consent Order and that they agree to be bound by the same. Plaintiff was represented by counsel, Jody Stuart Foyles of Foyles

Law Firm, PLLC, and she is satisfied with the legal services her counsel has provided to her in this matter. Defendant was represented by counsel, Thomas Van Camp of Van Camp, Meacham and Newman, PLLC, and she is satisfied with the legal services her counsel has provided to her in this matter.

Based on the foregoing Findings of Fact the Court makes the following Conclusions of Law:

- 1. All parties are properly before this Court and this Court has personal jurisdiction over the parties and subject matter jurisdiction of this action.
- 2. The parties have waived any right that they may have in regard to the *Macintosh v. Macintosh* decision.
- 3. Any Findings of Fact that would be appropriately included as a Conclusion of Law is incorporated herein as if fully set forth.
- 4. The parties waive any further Conclusions of Law and consent to the provisions set forth in the Order herein.

WHEREFORE, BY AND WITH THE CONSENT OF THE PARTIES, IT IS ORDERED, ADJUDGED AND DECREED AS FOLLOWS:

- 1. Defendant shall not visit, assault, molest, or otherwise interfere with the Plaintiff.
- 2. Defendant shall not stalk, harass, abuse or injure the Plaintiff.
- 3. Defendant shall not contact the Plaintiff by telephone, written communication or electronic means.
- 4. Defendant shall not enter or remain present at the Plaintiff's residence, school, place of employment or other locations at times when the other party is present at that location.
- 5. Defendant shall remain at least one thousand (1.000) feet away from Plaintiff at all times.
- 6. The Court shall and hereby does retain jurisdiction of this action for the entry of any further orders necessary to effectuate the terms and conditions set forth herein.
- 7. This Order shall remain in effect for 1-year unless extended or terminated by later orders of this court.
- 8. Thomas Van Camp and Jody Stuart Foyles are released as counsel of record in this matter.

9. A knowing violation of this civil no-contact order shall be punishable as contempt of court which may result in a fine or imprisonment.

June 16, 2020 - 11:53 PM I was alerted by my ring camera of someone outside my garage. I was able to view the Defendant looking through my car with a flashlight and attempted to open the vehicle. The police were called. She went to the side of my house and heard someone messing with the window. At that point I sounded the house alarm, She immediately ran up the street with her dog in hand. I called the police back to give them a description, the police caught the Defendant and she admitted to the police she was the individual I observed at my house.

On numerous occassions from July 11th to July 16th she has been passing by my home or passing by my boyfriend's house while I am at his house.

I am witnesseing her physically driving by my residence daily and there is no reason for her to be driving by my house. The Defendant owns firearms, has been trained in firearms and surveillance training in the Army. Given her obsession with me I am concerned by her escalating behavior and my physical safety.
