Re: Amendment And Supplementation of Felon Voter Protest in Wake

Dear Board Members,

On behalf of The Jefferson Griffin Campaign, I am writing to amend and supplement our election protest pending in front of the Wake County Board of Elections.

As you know the Jefferson Griffin Committee has filed election protests in all 100 counties. The NCSBE has assumed jurisdiction over three of the distinguished protest issues, while three others remain at the various county boards of elections.

We are writing to amend the Griffin Protest for Wake County related to voters ineligible by reason of a felony conviction. The legal grounds for the protest remain the same, but the class of voters affected or potentially affected is now different.

Specifically, the Jefferson Griffin Campaign wishes to add **Carl Duvée Barkley**, VRN 000100376860, to its felon challenge. As his North Carolina Department of Adult Corrections records demonstrate, Mr. Barkley is currently serving 48 years of active prison time for assault with a deadly weapon with intent to kill or inflict serious injury. *See Exhibit 1.* Mr. Barkley was convicted on October 28, 2024, and reported to prison on Election Day, after the return of his absentee ballot on October 7. Attached as Exhibit 2 is Mr. Barkley's voter history as shown on the State Board's website.

This supplement should be made part of the record before the Wake County Board. Individuals on this newly produced list will be served notice in the same manner as voters affected by our previous version of the challenges.

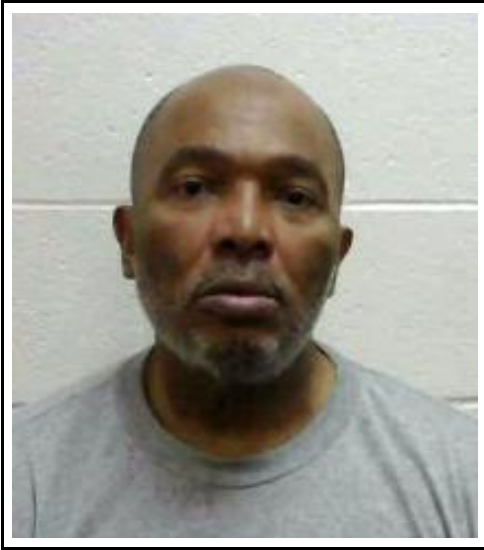
